# 2. DSRIP Implementation

## **October DY5 Reporting**

- October DY5 reporting is due <u>Monday, October 31, 2016</u> at <u>11:59pm</u>. All reports, documentation, and required templates must be entered or uploaded into the DSRIP Online Reporting System. Late submissions will not be accepted.
- Review & Payment Timeline:
  - November 1, 2016 HHSC will begin the review of October reporting submissions.
  - November 18, 2016 HHSC will post the estimated IGT due for October reporting based on milestones and metrics reported as achieved. Final IGT due will be based on HHSC review and approval.
  - November 21, 2016, 5:00pm Due date for IGT Entities to approve and comment on their affiliated providers' October reported progress on metrics. This process is optional.
  - December 2, 2016, 5:00pm Due date for submission of any IGT changes in entities or proportion of IGT among entities submitted to HHSC using the IGT Entity Change Form.
  - December 9, 2016 HHSC and CMS will complete their review and approval of October reports or request additional information (referred to as NMI) regarding the data reported.
  - o January 3, 2017 IGT settlement date for October reporting DSRIP payments.
  - January 13, 2017 October reporting DY5 DSRIP payments processed for transferring hospitals and top 14 IGT Entities.
  - January 16, 2017, 11:59pm Due date for providers to submit responses to HHSC requests for additional information (NMI requests)
  - January 31, 2017 October reporting DY4 DSRIP payments processed for all providers and DY5
     DSRIP payments processed for remaining providers that were not paid on January 13, 2017. Note that there are separate transactions for each payment for each DY.
  - **February 24, 2017** HHSC and CMS will approve or deny the additional information submitted in response to HHSC's NMI requests from October reporting.

## **Compliance Monitoring**

- There are a lot of questions and comments coming in about Compliance Monitoring results:
  - Timing. We realize that the timing would be better if providers received review results prior to reporting period and we were aiming that way, however, MSLC did not have enough time to share the results prior to reporting period. Having this information now probably assisted some providers in decision making for DY5 reporting.
  - o We will make additional adjustments for the next rounds of review.
  - Category 1 and 2 Round 1. HHSC has completed its review of MSLC findings for Round 1. HHSC will
    provide anchors with summary of the information for Round 1.
  - o Category 1 and 2 Round 2. HHSC is reviewing MSLC findings from Round 2.
  - o DSRIP team sent out communication to certain providers with CC to anchor informing them that additional work may need to take place to do additional validation of data for certain projects, and

that this work should take place during the NMI period. The impacted projects had DY3 carryforward.

- As HHSC continues to review, we may request additional information from providers.
- We anticipate that we will complete the initial review of Round 2 Category 1 and 2 by mid-November and determine what additional information is needed.
- Category 3 Performance Review Round 1: HHSC is still reviewing results of Category 3 performance review and will have more details on any impacts to payment at a later date.

## **Category 3**

• **DY6 Alternate Achievement Requests:** HHSC is currently reviewing responses from providers required to submit additional information and hopes to have final notice of approval the first week of November.

### **Anchor Administrative Costs**

- The next submission date for reporting administrative costs is November 15, 2016.
